#### **Hamilton Athletic Trust**

Assist a broad spectrum of amateur sports in the Hamilton-Wentworth Region. Organizations that are "self-supporting", will be given greater consideration for funding than those organizations that receive public funding as is the case with school-sport or provincial/nationally sponsored sports teams /athletes. Grants are meant to apply for the most part to teams and organizations that are more directly involved in organized competitive events and/or leagues. Grant cut off dates are April 30th and October 31st.

### Allegra Footprint Fund

The FootPRINT Fund® helps local eligible nonprofit and charitable organizations enhance their image, expand their services and extend their printing budgets utilizing Allegra's marketing and print services. Services are awarded with a maximum value of \$1,000 per organization for the award year. Services can include graphic design, printing, copying and interior signage. Promotional products are not eligible for FootPRINT Fund awards.

Also available: Posters with Purpose program: receive up to 50 full colour customized posters free to non profit and charitable organizations providing print ready file. Annual Brand Builder Award (Value \$3500) helps non-profit organizations develop a blueprint for success, by clearly defining and differentiating their organization and developing a strategy to move the brand forward. Grants are restricted to charitable organizations in the greater Hamilton area, although local initiatives of charitable organizations with a national presence will also be considered. Projects in the following areas are eligible: Arts and Culture; Conservation; Education; Health; Sciences; Social Services; Sports and Recreation. The grants ranged between \$1,000.00 and \$6,000.00. Grant requests should be submitted by October 1st.

Final decisions about grants will be made by the Board at the end of June. All applicants should be incorporated, non-profit organizations and have a valid charitable/business number from Canada Revenue Agency, or First Nations Bands designated as qualified donees.

# **Investor's Group**

IG supports programs that benefit local communities and fall within one of these general categories: arts and culture, civic causes, education and youth, environment, health, social services and amateur sport and recreation. Sponsorship is also available for community events, Most of the support is allocated at the local level. Local requests can be emailed directly to localcommunityrelations@investorsgroup.com

National programs need to submit an online application. They fund organizations that are federally registered charities and projects or programs that take place in communities where Investors Group has a business presence. Proposals are evaluated based on benefiting individuals in need, aligning with IG's objectives, employees that are actively involved as volunteers and programs that provide a unique service to an underserved community. National requests are generally less than \$5000

## The Keg Spirit Foundation

The Keg Spirit Foundation grants are typically in the range of \$2,000 to \$5,000. The application process consists of two-stages: an initial Letter of Interest, which if invited, is followed by a full proposal. The initial Letter of Interest must be limited to one page and should include: A description of the organization and indication of competence in the area of this proposal. An outline of the project including: a) Who it will benefit b) Design of the project c) Outcomes expected. A brief (2 or 3 lines) overview of your budget, income sources, and expenses for this project. The Keg Spirit Foundation will consider funding for both new and established projects based on the following criteria: a current charity registration number, related to children or youth in some way, containing a mentoring component. Letters of Interest may be submitted throughout the calendar year and are reviewed on an ongoing basis. Funding decisions are traditionally made in the first quarter of the year based on the prior year's proposals.

### **Forzani Group Limited**

The Power of Sport for Kids community giving program provides opportunities for sports, play and physical activity to deserving children who may not otherwise have the resources to take part. To be eligible to participate, your organization must meet the following criteria: must be a community group or non-profit agency, work with disadvantaged or at-risk children between the ages of 5-18 years, incorporate a recreation program into your curriculum, have some private funding as part of overall budget (not be 100 per cent government funded), be invited to participate by an employee of FGL Sports.

## **CIBC Community Investment Program**

Canadian registered charities or non-profit organizations that have projects aligned to CIBC's commitment to Kids, Cures or Community. Projects that provide children and youth in-need with education and training, mentoring, self-esteem and leadership skills as well as healthy and active lifestyles are eligible.

Projects must address a community need and provide direct impact to the community served (CIBC prefers to fund programs and projects rather than bricks and mortar) Funding requests are reviewed regularly throughout the year. While a decision will generally be made within 8 weeks following a submission, it may take up to 16 weeks before a decision is made depending on the size and complexity of the request.

The organization must be a registered charity and the project must have relevancy to the past and future of the community in which it operates. Grant Applicants will be accepted throughout the year until the end of December each year. Successful applicants will be notified by March 31st of each year and funds will be disbursed in the second quarter of the year.
